Executive Report

As Naples Therapeutic Riding Center continues to evolve, and demand for our most precious resource – our horses – and the healing they provide continues to grow, so too must we. This, our first-ever annual report, is evidence of our growth as a robust, thriving non-profit and a symbol of how much we value our donors' investment in our mission.

Through your contributions, we have harnessed the therapeutic power of our horses, allowing us to expand our reach and help more people in need than ever before.

Equine therapy is a fast-growing, innovative approach being used across the nation for everything from trauma and addiction to autism and multiple sclerosis. Our programs now involve caring for a horse, therapeutic horseback riding, horsemanship, education and much more, utilizing the most cutting-edge science to advance healing.

Over 20 years ago, NTRC mastered helping children and adults with physical and learning disabilities. Now, in addition, veterans, victims of trauma and people with behavioral health challenges are benefitting from time with our herd.

With your support, children who couldn't walk are walking, stroke victims who couldn't use limbs are holding their reins, people with autism are finding their voice, and people who have experienced trauma are easing anxiety and learning to trust – all by harnessing our herd's strength, intuition and ability to nurture. They are taking small steps and getting big results – all because of you.

Following the successful completion of our \$4 Million capital campaign, The Clark Family Foundation Equine-Assisted Therapy Center opened in late 2017, significantly expanding our campus and service capacity. In 2018, we served more than 800 participants by expanding programs and collaborations, adding educational opportunities for volunteers and professionals nationwide, and providing new avenues for the community to support our efforts. This was made possible with the help of our dedicated and highly trained 15-member professional staff and team of 350 volunteers, the heart and soul of our operation, who provided an estimated 18,000 hours of in-kind services last year to support our programming.

Looking forward, we are committed to bringing equine therapy to all who can benefit from the healing power of our horses. The board is focused on strengthening our impact and programs, communicating the value of this important work and evaluating our capacity.

Thank you for bringing smiles to the faces of our participants, volunteers and staff. Every gift helps make miracles happen on and off our horses.

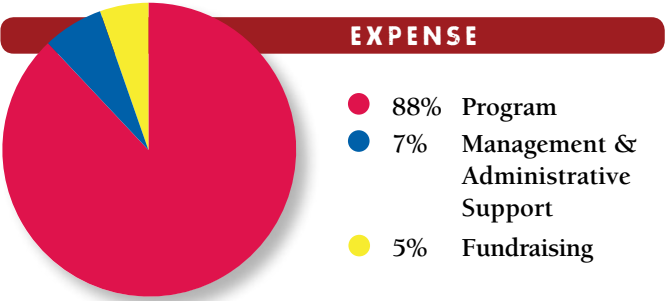
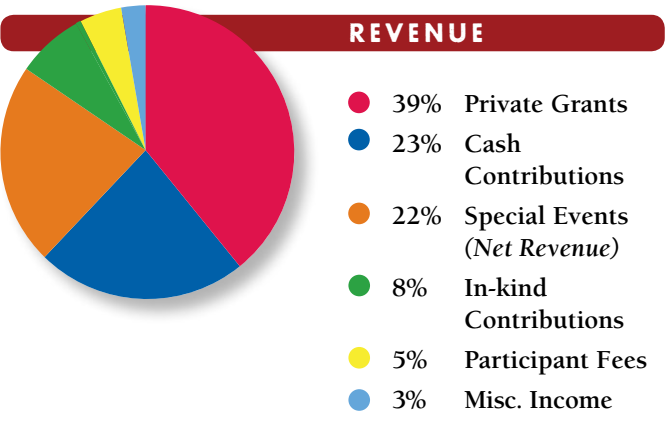
